County Council MINUTES April 24, 2018

Present – President Jennifer L. Williams, Vice President Corey W. Pack, Dirck K. Bartlett, Chuck F. Callahan, Laura E. Price, County Manager R. Andrew Hollis and County Attorney Anthony Kupersmith. Assistant County Attorney, Mary O'Donnell was absent.

- I. <u>Agenda</u> Ms. Williams requested and received Council's unanimous consent for approval of the Agenda of Tuesday, April 24, 2018.
- II. <u>Minutes</u> Ms. Williams requested and received Council's unanimous consent for approval of the Minutes of Tuesday, April 10, 2018.
- III. <u>Disbursements</u> Ms. Williams requested and received Council's unanimous consent for approval of the Disbursements of Tuesday, April 17, 2018 and Tuesday, April 24, 2018.
- IV. Presentation of Proclamation to Major Horace Johnson, Jr., Talbot County Department of Corrections The Clerk read a proclamation into the record which spoke of Major Johnson's distinctive service and rise through the ranks in the Talbot County Department of Corrections during his 30-year career with the Department. Doug Devenyns, Director of the Department of Corrections, spoke of Major Johnson's positive influence on his co-workers in the Department of Corrections and on the Department itself, and stated that he will be missed. Upon motion by Mr. Pack, seconded by Mr. Callahan, the Council approved the proclamation by voting 5 0 as follows:

Council members expressed their appreciation to Major Johnson for his three decades of service to the citizens of Talbot County and stated that his experience, presence, and mentoring of younger officers will be missed. Major Johnson thanked the Council for their support of the Department of Corrections through the years, and stated that it had been a pleasure to have worked with staff at the Department of Corrections and County Manager, Andy Hollis.

V. Presentation on National Drug Take-Back Day – April 28, 2018 – Joe Gamble – Talbot County Sheriff; Capt. Scott Merganthaler, Talbot County Sheriff's Office – Sheriff Gamble and Capt. Merganthaler briefed the Council on the upcoming National Drug Take-Back Day on Saturday, April 28, 2018, a nationwide initiative to provide a safe, convenient and responsible means of disposing of expired and unused prescription and over-the-counter drugs while educating the public about the abuse of such medications and the danger of flushing medications. Sheriff Gamble stated that the Sheriff's Office located at 28712 Glebe Road now has a prescription and over-the-counter medications drop-off box which is available to the public 24/7. He stated that

24/7 medication drop-off-boxes are also available at the Maryland State Police Barrack on U.S. Rt. 50 and at the Talbot County Department of Corrections, 115 W. Dover Street in Easton.

VI. Request by Talbot County Board of Education for Categorical Budget Transfers - Charles Connolly, Director of Finance, Talbot County Public Schools; Lynne Duncan, Assistant Superintendent for Administrative and Support Services, Talbot County Public Schools – Ms. Duncan stated that Dr. Griffith was unable to be in attendance as she was at the Maryland State Department of Education awards ceremony where Pam Clay, Supervisor, Career and Technology Education (CTE), Talbot County Public Schools, was receiving a Secondary Distinguished Service Award for making the highest meritorious contributions to the improvement, promotion and implementation of secondary career education. Mr. Connolly stated that the Board of Education had received unanticipated revenues from the Maryland State Department of Education for Special Education residential placements in the sum of \$52,712 and out-of-county placements by the Department of Juvenile Services in the sum of \$39,380. He stated that interest earned in the General Fund from State and County monies totaled \$20,847, bringing the total amount of unanticipated revenues received to \$112,939. Mr. Connolly requested to increase the Board of Education budget in the Special Education category by \$52,712, and the transportation category by \$60,227 for a total of \$112,939. Council discussion ensued with Mr. Connolly. Upon motion by Mr. Pack, seconded by Mr. Callahan, the Council approved the request as presented by voting 5 - 0 as follows:

VII. Introduction of Legislation:

A BILL TO APPROVE A LAW ENFORCEMENT MUTUAL AID AGREEMENT BETWEEN TALBOT COUNTY, MARYLAND, THE TALBOT COUNTY SHERIFF'S OFFICE, THE TOWN OF EASTON, THE COMMISSIONERS OF ST. MICHAELS, THE COUNCIL OF TRAPPE, THE COMMISSIONERS OF OXFORD, AND THE TOWN OF QUEEN ANNE IN ACCORDANCE WITH MARYLAND CODE ANNOTATED CRIMINAL PROCEDURE ARTICLE SECTION 2-105 was read into the record by the Clerk and brought forward for introduction. The legislation was introduced by Mr. Bartlett, Mr. Callahan, Mr. Pack, Ms. Price, and Ms. Williams as Bill No. 1388. A public hearing was scheduled for Tuesday, May 22, 2018 at 6:30 p.m. in the Bradley Meeting Room, South Wing, Talbot County Courthouse, 11 North Washington Street, Easton, Maryland 21601.

VIII. <u>Public Hearings</u>:

Resolution No. 259, A RESOLUTION TO AMEND THE TALBOT COUNTY COMPREHENSIVE WATER AND SEWER PLAN TO RECLASSIFY AND REMAP CERTAIN PROPERTIES LOCATED ON HOWELL POINT ROAD IN THE TOWN OF TRAPPE, MARYLAND, DESCRIBED AS TAX MAP 301, PARCELS 1780, 1897, 1898, 1900, 1901, 1902, 1903, 1904, 1905, 1905A, 1905B, AND 1906, FROM THE CURRENT CLASSIFCATION OF "S-3" TO "S-1", IMMEDIATE PRIORITY STATUS, was read into the record and brought forward for public hearing. Prior to the public hearing, Ray Clarke, County Engineer, stated that the Town of Trappe had contacted his office in January regarding the Town's application to request capital funds from the Maryland Department of the Environment (MDE) to upgrade the Town's water system and to add a new production well for the Town. Mr. Clarke stated that MDE requires the Town's application to include an amendment to the County's Comprehensive Water and Sewer Plan for a capital project in order to

position the Town for grant funding and low interest loans in FY2020. Mr. Clarke stated that it is the opinion of the Office of Law that the proposed amendment to add the production well as part of Resolution No. 259 is substantive and therefore requires that the public hearing be re-advertised. He stated that the Talbot County Planning Commission and the Public Works Advisory Board will be holding their respective meetings on Wednesday, May 2, 2018 and will be reviewing the proposed amendment. Council discussion ensued with Mr. Clarke who clarified that Talbot County, as custodian of the Comprehensive Water and Sewer Plan is acknowledging the Town of Trappe's capital project, the County is not adding a capital project. Upon motion by Ms. Price, seconded by Mr. Callahan, the Council introduced an amendment to Resolution No. 259 which would, if approved, add a new production well for the Town of Trappe as a capital project. The Council introduced the amendment by 5-0 as follows:

The public hearing on Resolution No. 259 was continued to Tuesday, May 22, 2018 at 6:30 p.m. in the Bradley Meeting Room, South Wing, Talbot County Courthouse, 11 North Washington Street, Easton, Maryland 21601.

Resolution No. 260, A RESOLUTION TO APPROVE EXECUTION OF A LEASE OF APPROXIMATELY 1,600 SQUARE FEET OF SPACE AT THE TALBOT COUNTY BUSINESS CENTER, 28712 GLEBE ROAD, EASTON, MARYLAND 21601, FURTHER DESCRIBED AS TAX MAP 25, PARCEL 58, TO KABAM STUDIOS, FOR A TERM OF ONE (1) YEAR WITH BASE RENT OF FOUR HUNDRED DOLLARS (\$400.00) PER MONTH, was read into the record, brought forward for public hearing, and the public was afforded an opportunity to comment on the legislation. Upon motion by Mr. Pack, seconded by Mr. Callahan, Resolution No. 260 was brought to third reader with the Council voting 5 – 0 as follows:

Upon motion by Mr. Pack, seconded by Ms. Price, Bill No. 1385 was brought to third reader with the Council voting 5-0 as follows:

Bid No. 17-21, REQUEST FOR PROPOSALS: DEVELOP NEW ZONING DISTRICT, A WORKING WATERFRONT OVERLAY DISTRICT FOR INCLUSION IN THE TALBOT COUNTY CODE – Requested Council approval to award Bid No. 17-21 to the sole bidder, White & Smith, LLC, in a sum not to exceed \$52,696.00 as consultant for the project; funding for the project is being provided by a grant in the sum of \$50,000 from the Maryland Department of Natural Resources Working Waterfronts Program with the remaining portion funded by the County. Ms. Price requested that Miguel Salinas, Assistant Planning Officer, contact White &Smith, LLC regarding the feasibility of lowering their price to \$50,000, the amount of the DNR grant.
